RESOLUTION NO. 03.03.25

A RESOLUTION OF THE CITY OF HEREFORD, TEXAS FINDING THAT THE STATEMENT OF INTENT OF ATMOS ENERGY CORP., WEST TEXAS DIVISION TO CHANGE RATES FILING WITHIN THE CITY SHOULD BE DENIED; FINDING THAT THE CITY'S REASONABLE RATE CASE EXPENSES SHALL BE REIMBURSED BY THE COMPANY; FINDING THAT THE MEETING AT WHICH THIS RESOLUTION IS PASSED IS OPEN TO THE PUBLIC AS REQUIRED BY LAW; REQUIRING NOTICE OF THIS RESOLUTION TO THE COMPANY AND LEGAL COUNSEL.

WHEREAS, the City of Hereford, Texas ("City") is a gas utility customer of Atmos Energy Corp. ("Atmos" or "Company") within the West Texas Division, and a regulatory authority with an interest in the rates and charges of Atmos; and

WHEREAS, the City is a member of Cities Served by Atmos West Texas ("Cities") (such participating cities are referred to herein as "Cities"), a coalition of similarly situated cities served by Atmos that have joined together to efficiently and cost effectively review and respond to natural gas issues affecting rates charged in the West Texas Division; and

WHEREAS, on or about October 25, 2024, Atmos filed with the City a Statement of Intent to Increase Rates seeking to increase natural gas rates by \$66.1 million annually and to all customers residing in the City; and

WHEREAS, Cities is coordinating its review of Atmos's Statement of Intent filing with designated attorneys and consultants to resolve issues in the Company's filing; and

WHEREAS, through review of the application, Cities' consultants determined that Atmos's proposed rates are excessive; and

WHEREAS, the Cities' members and attorneys recommend that Cities members deny the Statement of Intent; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HEREFORD, TEXAS:

Section 1. That the rates proposed by Atmos to be recovered through its gas rates charged to customers located within the City limits, are hereby found to be unreasonable and shall be denied.

Section 2. That the Company shall continue to charge its existing rates to customers within the City .

Section 3. That the City's reasonable rate case expenses shall be reimbursed in full by Atmos West Texas.

Section 4. That it is hereby officially found and determined that the meeting at which this Resolution is passed is open to the public as required by law and public notice of the time, place, and purpose of said meeting was given as required.

Section 5. ITEM 8 - Announcements and comments from City Staff.

City Manager Bartels provided an update on the following:

Xcel Energy is taking proactive measures to prevent wildfires caused by power lines. They will be updating the power lines on 15th Street and at the intersection of Highway 385.

TxDot is nearing completion of the sidewalks along Highway 385.

The final walkthrough at the complex is scheduled for Thursday, with a tournament planned for the following weekend. Contractors are currently paving the parking lot, and it will be striped next week.

He reported there was one tree casualty, which resulted in a fence being taken down due to the high winds.

He informed the Commission about the leak on 15th Street and Centre, the city staff is working to get the leak fixed.

He announced he will be out for vacation at the end of the week and all of next week.

City Manager Bartels thanked those in attendance.
