ORDINANCE NO. 03.03.25

AN ORDINANCE OF THE CITY OF HEREFORD, TEXAS DECLARING CATHY BUNCH ELECTED TO THE OFFICE OF MAYOR OF THE CITY OF HEREFORD, TEXAS, DECLARING ROSE MARY BARRETT ELECTED TO THE OFFICE OF COMMISSIONER PLACE ONE OF THE CITY OF HEREFORD, TEXAS, DECLARING CLINT SAVOINI ELECTED TO THE OFFICE OF COMMISSIONER PLACE THREE OF THE CITY OF HEREFORD, TEXAS AND CANCELING THE MAY 3, 2025 CITY OF HEREFORD, TEXAS OFFICERS' ELECTION.

WHEREAS, by Order of Election issued January 22, 2025, it was ordered that an election be held on May 3, 2025 for the purpose of electing the following officials of the City of Hereford, Texas:

Mayor; Commissioner Place One; Commissioner Place Three; and

WHEREAS, the City Secretary of the City of Hereford, Texas, has heretofore delivered Certification to the City Commission that the candidate, being Cathy Bunch, for election to the office of Mayor of the City of Hereford, Texas in the May 3, 2025 City Officers' Election is unopposed for election to that office and that the candidate, being Rose Mary Barrett, for election to the office of Commissioner Place One in the May 3, 2025 City Officers' Election, is unopposed for election to that office, and being Clint Savoini, for election to the office of Commissioner Place Three in the May 3, 2025 City Officers' Election, is unopposed for election to that office:

NOW THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF HEREFORD, TEXAS:

- 1. It is declared that Cathy Bunch is elected to the office of Mayor of the City of Hereford, Texas, and the May 3, 2025 City Officers' Election for the office of Mayor of the City of Hereford, Texas is canceled.
- 2. It is declared that Rose Mary Barrett is elected to the office of Commissioner Place One of the City of Hereford, Texas, and the May 3, 2025 City Officers' Election for the office of Commissioner Place One of the City of Hereford, Texas is canceled.
- 3. It is declared that Clint Savoini is elected to the office of Commissioner Place Three of the City of Hereford, Texas, and the May 3, 2025 City Officers' Election for the office of Commissioner Place Three of the City of Hereford, Texas is canceled.
- 4. A true and correct copy of this Ordinance shall be posted on Election Day at each polling place that would have been used in the election for the offices of Mayor, Commissioner Place One, and Commissioner Place Three of the City of Hereford, Texas.

The above and foregoing Ordinance was duly introduced on the motion of Commissioner Angle Alonzo, seconded by Commissioner Deven Black, and was duly PASSED, APPROVED AND ADOPTED by the unanimous vote of the City Commission on the 3rd day of March 2025.
